PLEASURE FOR ME five wide on the first turn, took command after a half mile, showed the way along the three path and then was ridden out to the line. SHOE FLY PIE rated off the rail, gained along the three path on the last turn, angled out in the lane and finished well to clearly best the rest. SUPREME JET broke sluggishly, tracked along the rail on the last turn and weakened. CHI CHI'S DREAM lagged far back, gained on the last turn and then flattened out. MAGICAL DOLL saved ground, was outrun. JULIA'S HALO set the pace early along the three path and gave way. MAGIC RIVER taken back at the start, saddle slipped and then could not be ridden to her fullest. DEMI GODDESS fractious in the gate, six wide on the first turn, tracked early and tired. L D'S GALAXY fractious loading in the gate, lagged back and then was eased entering the lane.
