### Footnotes

SHETLAND ISLAND well placed and inside, gained a striking position on the two path through the turn, took command quickly into the stretch, then drew off and held under steady pressure. DONTRAINONMYPARADE allowed to settle, moved up inside through the turn, angled out to bid three wide, then made a steady gain through the lane to get up for the place. IVORY LIGHTNING well placed and off the rail, gained position three wide through the turn, bid on that path into the stretch and flattened out. YVONNE'S DELIGHT passed a tiring rival for a share. HOWYADOODLIN stalked the early pace outside and had no rally. ELEGANT EXPRESSION void of speed, moved up inside. DEFERRAL showed little. T. Y. MIRACLE sprinted to a clear lead quickly and stopped after a half.
