Footnotes

RONNIES FOOTNOTES was unhurried, gained along the three path into the lane, collared the leader and drove clear. PRO'S PAL ran for purse only, vied for the lead along the two path on the turn, battled in the lane and then drifted out late. BLUESPOWERHOUSE was unhurried, gained along the rail on the turn, altered to the outside for room and then checked late. PEGASUS ENA broke slow, lagged back, two path on the turn, altered out leaving the eighth pole and finished well. DOC CAN DO was well placed early, four path on the turn and weakened. HEAD HEART HOOF vied for the lead to the lane and gave way. A stewards inquiry was posted concerning the stretch run. Also a claim of foul was lodged by the rider of BLUESPOWERHOUSE against PRO'S PAL for alleged interference in deep stretch, was not allowed.
