ALLEN'S AFFAIR broke on top, contested the lead along the rail, kicked clear in upper stretch and under the whip proved best. WITH OPTIONS broke slow, saved ground on the turn, eased out for room leaving the eighth pole, responded and rallied. TRACKMENS STAR was unhurried, saved ground on the turn, checked at the top of the lane, eased out, asked and rallied. MERCER CROSSING was well placed along the rail, continued inside into the lane, altered out for room leaving the eighth pole and hung. OFFSHORE SCORE never far back, two path on the turn, angled out some and hung. THEUNTRAINEDEYE was well placed five wide up the backstretch, three path on the turn and weakened. SWIFT TO THE BID was unhurried four from the rail up the backstretch, took the two path on the turn and then lacked a rally. BRAVE WILLY B was well placed four wide up the backstretch tracking the leaders, took the three path on the turn and weakened. GOTAGETTHERGREEN vied for the lead along the two path with the winner to the lane and tired. CRIMINAL JUSTICE broke sluggishly, two path on the turn, was outrun. TRUANCY unhurried five wide up the backstretch, continued wide into the lane and finished wide.
