FUTURAZO broke on top, set the pace off the rail, was hooked from both sides in midstretch, responded to the challenge and under the whip got the job done. BULLNOSE BRICK was well placed, gained along the rail on the last turn, lodged a bid inside looking like a winner with a furlong to go and then hung in the crucial stages. POWHATAN COUNTY stalked along the three path up the backstretch, continued on that path into the lane, challenged some three across in midstretch and weakened. PURA P T broke slow, lagged back along the rail on the turns and then failed to take part. RICKYONTHERUN was well placed between foes up the backstretch, two path on the last turn and weakened. AUDIES CHAMP was well placed three across up the backstretch, three path on the last turn and tired.
