BIG POLK A DOT tracked along the three path on the turn, responded late and nailed CLASS CLOWN on the line. CLASS CLOWN vied for the lead early, kicked clear up the backstretch, drifted in when challenged with a furlong to go making it tight on JOHN G C and then just missed. JOHN G C was well placed along the rail, lodged a bid inside to gain on the leader, checked some leaving the eighth pole and then weakened. KING KONG KINGDOMS never far back, saved ground and then finished with interest. TITUSVILLE lagged back, three path on the last turn and then failed to gain. A claim of foul was lodged the rider of JOHN G C against CLASS CLOWN for interference in midstretch, was not allowed.
