WABASH RIVER in hand along the two path up the backstretch, asked on the last turn, entered the lane three from the rail, collared the leader in gear and drove clear. CALL TIGER in hand four from the rail close up after a half mile, asked on the last turn, gained into the lane and finished well. PERRY LANE rated along the rail, took the three path up the backstretch, asked into the lane and finished well. CINNER DAVE was well placed four from the rail up the backstretch, gained leaving the backstretch, challenged three across midway on the last turn, took the lead and then weakened. FIRE IN HIS EYES contested the lead in hand three across up the backstretch, between foes midway on the last turn and faded. AOJA set the pace while pressed along the rail to the last turn and gave way. TEN BELLS forced issue briefly, saved ground and tired.
