DAKOTA ROADHOUSE set the pace while pressed, kicked clear some on the turn, was hooked and then finished well to best the rest. DAVID IS MAD never far back, saved ground, gained some and then weakened. DIAMOND DISTRICT broke sluggishly, saved ground and then failed to respond. JUNALUSKA was well placed along the two path on the turns and tired. TISNOW JULIE three path on the turns, was done early.
