GALAXY EXPRESS was unhurried, gained five wide on the last turn, collared the leader, battled and under the whip proved best. DIAMOND DISTRICT was well placed along the four path up the backstretch, took charge on the last turn, was hooked, battled and finished gamely. SOPHIE'S SPLINTER was well placed, five wide on the last turn, tracked the leader into the lane and then weakened. CASH FOR GOLD vied for the lead along the rail and weakened. MAJOR DOME was well placed, gained along the four path on the last turn and flattened out. EASY SPUR lagged back, was never in it. ROYAL MAJESTY vied for the lead up the backstretch and then was done on the last turn. ODOR FREE saved ground on the first turn and tired.
