### Footnotes

WILLY'S WICKED WAY was unhurried, gained along the three path leaving the backstretch, challenged three across at the top of the lane, took the lead and under the whip turned back JUDGE MARGARET for the win. JUDGE MARGARET was well placed in hand, saved ground on the last turn, angled out, asked and finished with good energy. LE CHESNAY broke well, set the pace along the rail, was hooked at the top of the lane, battled some and weakened. SPIN THE WHEEL tracked along the two path on the turns, challenged between at the top of the lane and then faded. ROYAL VESSEL was unhurried, four wide on the first turn, five wide on the last turn and weakened. HONEYMOON SUITE three path on the corners and weakened. CELTIC KETTLE was well placed up the backstretch, four path on the last turn and tired.
