MAKANI set the pace along the three path, responded when asked and drove clear. DEVI broke in the air, unhurried early, entered the lane five wide and rallied. CHARMING OFFICER was well placed, three path on the turn, lodged a bid and hung. SECOND MARRIAGE stalked the winner along the four path, chased in the lane and weakened. DAVID'S FLAME was unhurried five wide on the turn and then lacked a solid bid. DOVE NEST six wide up the backstretch, five wide on the turn and weakened. WIDOW TAPP broke in air, five wide on the turn and then failed to menace. CELTIC KETTLE an early factor off the rail and tired. BEAUTIFUL RIDE saved ground and tired.
