FIT FIGHTIN FELINE allowed to settle, moved up on the two path through the turn, was boxed into the stretch, waited, bid between rivals and edged ahead late. MEL AN ME well placed and outside, looped up four wide through the turn, fanned widest into the stretch and lacked the needed late kick. RAFFIE'S FACTOR tracked the pace on the inside, held position through the turn, was blocked into the stretch, angled out to find racing room and found opening too late. KING KEENE stalked the early pace on the outside, moved up to bid outside that one into the lane, edged ahead at the furlong marker, then shortened stride and weakened. GO FOR TWO improved position. MUY MAN set the early pace off the rail and faded the final furlong. CALEB'S A SURVIVOR was no factor. A CLAIM OF FOUL LODGED BY THE RIDER OF MEL AN ME AGAINST THE RIDER OF FIT FIGHTIN FELINE, WAS NOT ALLOWED
