Footnotes

BEDROCK BLUES was unhurried, gained along the three path on the last turn, quickly took command and under the whip proved best. GIMMEANOTHERWINK stalked, dueled after a half mile, shook loose on the last turn, responded and came back on for the place. PRINCEOFPROXIMITY lagged back, saved ground on the first turn, gained along the four path on the last turn, drifted in entering the lane bothering CROMWELL ALLEY and then finished well. ASK OMMADON was well placed, tracked along the three path on the last turn and weakened. CROMWELL ALLEY was well placed, three path on the final turn, bothered by PRINCEOFPROXIMITY into the lane, checked and weakened. KING'S FEZ was well placed, two path on the last turn and weakened. THE PLOT THICKENS broke well, set the pace, was hooked after a half mile and then was done on the last turn. A stewards inquiry was posted along with a claim of foul by the rider CROMWELL ALLEY against PRINCEOFPROXIMITY for interference entering the stretch, was not allowed.
