### Footnotes

AVA MARISA tracked along the four path on the turn, angled out in the lane, responded, gained the lead late and was going away at the end. CITRINE assumed command, set the pace along the three path, was hooked, battled some and then held the place. LADY ROCK N ROLL was unhurried along the four path on the turn, angled out in the lane and rallied. DEVIL'S LAST DANCE was slow to load, well placed along the three path on the turn, angled out and closed well. LEAP TO FAME was well placed while five wide on the turn, angled out, lodged a bid and hung. ONE EL OF A LADY lagged back, saved ground, three path on the turn and then lacked a response. DAZZLE ME DARLIN five wide on the turn and then continued wide in the lane. SHE'STENONTOP four path on the turn and tired. SHEA D'LADY lagged back and then was six wide on the turn.
