STRONG CASE vied for the lead from between foes early, shook loose on the bend and then was ridden out to the line. TOOT TA ROO tracked the winner along the rail, eased out in the lane, gained and then finished clearly best of the rest. LAKE ISLE DRIVE was unhurried while five wide on the turn, angled out in the lane and then closed well to earn a share. MT. CLASSIC was unhurried along the three path on turn, eased out some and finished with interest. WILDMAN WESLEY forced the issue inside early and weakened. CASH ME OUT six wide on the turn and then continued wide in the lane. SIR KNIGHT SHOT four path on the turn and then angled wide for the drive. PROWLING WOLF forced the issue while four abreast early and tired. MERCALI showed little. RODEO RUNNER lagged back, gained inside in the lane, lacked room at the sixteenth pole and then checked to the line.
