GOOD LAW was unhurried, circled foes on the last turn, took charge into the lane and under the whip was all out to narrowly turn back MAJESTIC JOY for the win. MAJESTIC JOY was well placed along the four path, entered the lane three wide, asked, gained, battled and finished gamely to just miss. PROLIFIC APPEAL was unhurried along the three path, off the rail on the last turn, gained some but was no match for the top two. TOO DRUNK TO CALL set the pace along the rail and weakened. GEBB'S POWER sluggish start, lagged back while six wide up the backstretch, was outrun. BAD BOY RISING tracked the leader while five wide and tired. PLUNDER AN PILLAGE tracked along the four path, dropped back on the final turn and then was being eased through the final furlong.
