ROYAL IRISH LACE assumed command, set the pace, was collared by the winner with a furlong to go, battled and missed in a game try. RUN WITH NETTI was unhurried early, gained ground when asked on the final turn, lodged a bid outside in the drive and was gaining. WATRALS TWELVBELOW gave way. SAIGONEVE showed little.
