Footnotes

CINNER DAVE was unhurried, gained four wide on the last turn, rallied, drifted in nearing the sixteenths pole making it tight on SHOW THE FLAG and then outran that one to the line. SHOW THE FLAG never far back, gained four wide on the last turn, angled in some for the drive, altered out late when the winner came down some and then finished well. HI POPPY vied for the lead inside, battled in the lane and faltered late. SMALL TOWN was unhurried, three path on the last turn, angled out and closed well. COME ON OVER was well placed four wide on the first turn, tracked the leaders along the three path on the final turn and weakened. NEVER GIVE UP was well placed, saved ground on the last turn and weakened. CORVO lagged back, saved ground, was outrun. FACE IN THE MIRROR saved ground on the first turn, three path on the last turn and tired. TWO CATS was well placed up the backstretch and tired. LEGAL TENDORA vied for the lead along the two path on the turns and tired. A claim of foul was lodged by the rider of SHOW THE FLAG against the winner for interference at the sixteenths pole, was not allowed.
