SUNDAE ON SUNDAY never far back, ran evenly to the stretch, came through inside of rivals, angled out and closed for the place, while no threat to the winner. IDOL IMAGE allowed to settle, came through inside into the stretch, evened out in the lane, while gaining the show spot. SACRED GROUND passed tiring rivals. POWHATAN COUNTY well placed and outside, steadily lost ground. PASSING TIME tracked the pace off the rail, angled out to bid outside into the stretch and faded the final furlong.
