DEVIL BY SANDY vied for the lead early, tracked, three path on the last turn, angled out, responded and nailed LOOPY DE LOOP on the wire. LOOPY DE LOOP broke on top, vied for the lead early, shook loose, showed the way and then just missed. BEHRACUDA never far back, two path on the turns, eased out and finished with interest. WHO'S RALPH broke slow spotting his field a length, saved ground in striking distance and weakened. NORTH PARK BAND well placed up the backstretch, four path on the last turn and weakened. PAY THE JUDGE ducked out at the start, four wide into the lane and tired. INDIAN FALLS was well placed along the three path on the turns and tired.
