CRIMINAL JUSTICE lagged back, gained along the rail leaving the backstretch, eased out into the lane, asked and closed fast for the win. KEY GRIP vied for the lead along the three path, shook clear on the last turn, opened up in the lane and then drifted out through the final sixteenths to miss. MIDNIGHT TUCKER was well placed along the three path, continued on that path on the last turn, chased and finished with interest. UNGUIDED MISSILE lagged back along the three path, three path on the last turn, angled out and made a mild bid. TRACKMENS STAR unhurried, gained four wide on the last turn and flattened out. BUTTERFIELD ROAD was well placed saving ground and weakened. JESSIE TOWTRUCK broke sluggishly, lagged back, five wide on the last turn and then failed to threaten. LIFE OF A TIGER was unhurried four wide leaving the backstretch and tired. KELLY'S CAPER was well placed four wide up the backstretch, four path on the last turn and tired. TRUANCY vied for the lead along the rail for a half mile and tired.
