Footnotes

PRO'S PAL fractious in the gate, broke sharply, set the pace, responded when challenged, drew clear and then was kept the whip. BLUESPOWERHOUSE unhurried, drifted in nearing the quarter pole bothering SYSTEM RESTORE slightly, angled out in the lane and finished well. OVEREXTENDED lagged back along the two path, angled out and made a late bid. SYSTEM RESTORE unhurried along the rail, bothered slightly nearing the quarter pole, checked briefly and then lacked rally. PATRON SAINT four path on the turn and weakened. DOC CAN DO stalked the winner along the three path, gained some and then tired. MR. REAL DEAL four path on the turn and tired. A claim of foul was lodged by the rider of SYSTEM RESTORE against BLUESPOWERHOUSE for interference at the quarter pole, was not allowed.
