CARLOW vied for the lead along the three path after a half mile, between foes nearing the quarter pole, shook loose in the lane and under the whip held sway for the win. FLY TO ME was well placed along the rail, angled out to the four path on the last turn, challenged some while three abreast nearing the quarter pole, chased the winner to no avail but finished second best. LINE MEMORY lagged back, saved ground on the last turn and then was no match for the top two. RAF'S SOCIETY GIRL set the pace early, vied for the lead along the three path after a half mile, battled some at the top of the lane and faded. NEIGH HIGHS four path up the backstretch and weakened. LOVE BOOT five wide on the first turn, well placed up the backstretch and tired. A claim of foul was lodged by the rider of FLY TO ME against the winner for interference at the top of the lane, was not allowed.
