TWO DECADES never far back saving ground, slipped inside into the lane, collared the leaders in midstretch, responded drove clear for the score. EMBRACE LIFE was well placed, five wide up the backstretch, gained five wide on the last turn, collared the leaders into the lane, battled to no avail but held the place. DIAMOND DISTRICT ducked out start, well placed along the four path, challenged between nearing the quarter pole, battled, in tight in midstretch, checked, altered course to the rail and finished well. WESTERN DEED forced the issue along the four path, dropped back into the lane and made a late bid. CINNER DAVE was unhurried five wide up the backstretch, five wide on the last turn, lodged a bid and hung. BROCCO VALLEY set the pace while pressed and weakened.
