### Footnotes

MOTION TO APPEAL stalked along the two path on the corners, challenged for the lead at the top of the stretch, battled and under the whip edged clear. FUTURAZO broke well, set the pace along the rail, battled the winner into the lane to no avail but bested the rest. BUDGE MAN was well placed in hand off the rail, eased out and finished with interest. PIANO STAR was well placed along the three path on the turns and weakened. HUBBARD was unhurried in striking distance along the three path on the turns and tired.
