### Footnotes

JABEZ tracked along the three path, kicked clear two off the rail on the turn and then drifted out to the line while clear. WHO'S ZAT GIRL was well placed along the four path, gained three from on the turn, altered in for room nearing the sixteenths pole and finished well. CATILLAC CUTIE reared at the start spotting the field three lengths, two path on the turn and then finished well. MY PERCEPTIVE GIRL saved ground early, bore out some on the turn and then finished wide. ELTISH'S WILDFIRE saved ground, was not a factor. BUMBLEBEE BOOGIE set the pace early off the rail, tracked inside into the lane and tired. BREATHLESS BLUES two path on the turn, was outrun. A stewards inquiry was posted concerning the start, resulted in no change. A claim of foul was lodged by WHO'S ZAT GIRL against the winner for interference in the stretch, was not allowed.
