### Footnotes

MEL AN ME was well placed two off the rail leaving the backstretch, took the fence around the turn, two path into the lane, launched a bid inside and under steady whipping edged clear for the win. SIR HOLLISTER stalked along the three path rounding the bend, moved to take a clear lead in midstretch but could not handle the winner. FIRSTBELLATHENKK broke well, set the pace two off the rail around the turn, was hooked leaving the three-sixteenths pole, chased outside and weakened. BULLY BULLY BROWN broke slow, was unhurried saving ground and then failed fire. IRUSAN never far back five wide up the backstretch, three path on the turn and tired. LUCKY ALY was well placed four from the rail early, appeared in distress, pulled up and then walked off.
