### Footnotes

TWO CATS broke on top, set the pace along the rail, responded when challenged and drove clear late. DIAMOND DISTRICT was well placed in hand along the rail, eased out into the lane, asked and was up for the place. NEW YORK STYLE gained four wide on the last turn, challenged in midstretch, battled to no avail but stayed on well. CALL TIGER was unhurried along the two path on the turns, eased out and made a late bid. BRENDAN'S WARRIOR gained five wide on the last turn, loomed a threat and hung. BENSON stalked along the two path on the turns and tired. LEGAL TENDORA four wide on the first turn, tracked up the backstretch, closed along the three path into the lane and faded.
