SUSAN'S APPEAL was unhurried, gained along the three path on the turn, chased while drifting out through the lane and under the whip was along in time. TIME TO WIN broke well, set the pace while five wide on the turn, was hooked late, battled and finished gamely. TACONIC GIRL was well placed five wide on the turn, angled out and finished with interest. LITTLE CHAMPION lagged far back, angled wide in the lane and made a late bid. MY DESERT QUEEN was well placed, seven wide up the backstretch, six wide on the turn, continued wide in the lane and weakened. LUCY LUCY lagged back and then angled wide for the drive. POP'S PRINCESS stalked the leader while seven wide, six wide on the turn and tired. MODERN MILLIE nine wide up the backstretch and then was five wide on the turn. FAMILY VOW five wide on the turn and tired. DONTMATTER four path on the turn and tired. CITY FORTUNE eight wide up the backstretch, six wide on the turn and tired.
