MAGGIE'S PRINCE was unhurried, four path on the turn, angled out, rallied to take on the leaders in midstretch and drove clear for the win. BY REQUEST rated far back, two path on the bend, gained into the lane, altered course to the outside while in gear leaving the eighth pole and closed fast to earn the place. SEVEN FIRSTS was well placed, challenged along the three path at the top of the lane, battled in the lane to no avail but finished well. TAXED was unhurried, three path on the turn, responded and rallied. ALMOST A FOOLS DAY was well placed along the four path, challenged some in midstretch and weakened. MUSICOFMEADOWLAKE gained along the four path on the turn, dueled at the top of the lane, battled between and tired. BADGE MACHINE saved ground, lodged a bid and hung. DIVORCED DECISION saved ground, checked at the top of the lane and faded. TOM'S PRIMETIME saved ground, was outrun. JADES KNIGHT set the pace early, was hooked and gave way.
