### Footnotes

SHE'S MY IMAGE away well, was sent to the front, showed the way off the rail and then was never threatened while being ridden out. RAINBOW EXPRESS was well placed along the rail on the last turn, gained some and then finished well. AURIC GIRL rated along the rail, began to gain some along the three path into the lane and flattened out. MS. BIRD WATCH tracked the winner along the three path up the backstretch, continued on that path into the lane and weakened. MIRTHFUL FLIRT was well placed after a half mile, two path on the last turn and tired. LEVY LIGHT lagged back, gained some along the rail into the final turn and tired. STEPHEN'S EVEN lagged back and then tired along the three path on the final turn. NEVER KNOW four wide into the backstretch and then was done early.
