READY VICTORY was unhurried early, gained along the three path, entered the lane four wide, rallied to collar the leaders and drove clear. DAKOTA ROADHOUSE tracked along the three path, challenged at the top of the lane, drifted in some into the lane and finished well to best the rest. DADE CITY tracked along the two path, in tight in upper stretch, checked, battled and weakened. BRIGHTROCK saved ground, in tight in upper stretch, checked and then lacked a rally. D' FIGHTER was unhurried along the rail and then failed to fire. WISEMAN JACK four path on the turn and then failed to respond. JERICO RULES set the pace, was hooked at the top of the lane, in tight between in upper stretch, checked and weakened. NEVER GIVE UP four path into the lane, was outrun. DAZZLING DEREK three path on the turn and tired. A claim of foul was lodged by the rider of DADE CITY against DAKOTA ROADHOUSE for interference in upper stretch, was not allowed. Also the rider of JERICHO RULES lodged a claim of foul against DADE CITY for interference in upper stretch, was not allowed.
