GOOD LAW was unhurried, four path on the last turn, lacked room in midstretch, altered course to the outside and rallied. NO HALO ON ME was unhurried, gained along the three path on the last turn, challenged and hung. PRINCE RAFFIE lagged back, angled out in the lane and made a late bid. CLIENT EIGHT stalked, challenged at the top of the lane, battled and weakened. PRO'S PAL set the pace, was hooked at the top of the lane, battled and weakened. BOSTON CHIEF was well placed along the four path on the last turn and weakened. PEPPERONI was unhurried and failed to menace.
