SPECIALFITE was away alertly and set the pace, weakened at the top of the stretch and was gamely outfinished. HERECOMESTHEMANNOW pressed the pace along the rail with no rally. BIG CASH DEAL stalked the pace but failed to menace. JUMP TO THE CHASE was unhurried early, made a middle move, no menace. DR T HUDSON was allowed to settle, had a mild bid but was no threat. VESTAL showed little. TI TOWNSHIP stalked the pace, through after the half. CATHYDAVID'SDANCER showed brief speed and then stopped.
