Footnotes

WILLOW CREEK WILLY was a pace factor outside of SPEIGHTSTOWNLAWYER, dueled three wide to the stretch, dug in late, lugged out leaving the sixteenth marker but straightened quickly and held determinedly. BELLAGIO ROAD was outsprinted to the turn, advanced inside to the stretch, swung out into the stretch, rallied when set down for the drive, drifted inward slightly leaving the sixteenth pole but did not make contact with the winner and was bested. PERFECT FLIGHT chased the pace to the turn, bid three then four wide to the stretch but could not muster the needed response. SPEIGHTSTOWNLAWYER had good speed, dueled off the rail and inside the winner to the stretch, remained a factor to mid stretch then tired. FAR TO REACH chased the pace to the turn, came two wide to the stretch but lacked the needed late response. CAUSE HESA PISTOL stalked the leaders early, was outkicked while three wide to the stretch and also did not rally. PRINCETHEFIFTH had no speed and was not a factor. CALL ME A DOG chased the pace three wide early, was outrun to the stretch and did not threaten. SHAMINO tracked the leaders early, raced two wide on the turn but gave way in the drive. REALITY KICKS broke slow, fell far behind in the opening quarter, bore out on the turn then was eased in the stretch but walked off. The jockey on BELLAGIO ROAD lodged an objection against the winner for alleged interference in deep stretch but it was not allowed by the stewards who ruled that both horses had contributed to the incident.
