C O PEACE vied four wide on the lead outside rivals, continued to duel outside NO BAGGAGE through the turn, edged clear and drew off under mild urging. NO BAGGAGE dueled from inside the winner through the turn and could not match strides in the lane. DIVA IN TRAINING angled out to move five wide in the turn then moved up from widest in the lane. CHOCOLATE DIVA showed speed from along the inside to the turn and weakened nearing the lane. RARE CRYSTAL vied early from between rivals, angled four wide nearing the lane but had no rally. RUSH THE NET was not a threat racing four and five wide. HIGH SPEED JUSTICE failed to offer a bid racing three wide.
