**Footnotes**

HOWARD COUNTY HANK settled back off the leaders racing three to four wide, rallied through the far turn while angling out then swung seven wide into the stretch and closed with a good late run to reach the front in the closing fifty yards. QUINT'S MALAGRA stalked the pace from three or four wide, rallied through the lane to bid midstretch and lead briefly before being overtaken by the winner in the closing yards. BOND dueled from outside NEW KIRKS TRICK through a solid early pace, kicked well clear approaching the stretch but had nothing left in the final sixteenth. RACK OF BLACK moved up while angling out heading up the backstretch then lacked a final closing response. B. B. HILL leaned into the side of the gate to come away slowly, raced wide and moved up in the stretch. WIDOR was not a factor racing three or four wide. FAMILY BIZ was always back. NEW KIRKS TRICK dueled from inside BOND while placed about the three path and tired. FISHER COUNTY saved ground and was outrun. I THE JURY stalked the leaders from along the inside and tired.
