Footnotes

PERI PERI was allowed to settle early, moved up three wide at the eighth pole and finished gamely to be clear under all out pressure. SCENIC SHADOW pressed the pace, dropped back a bit down the backstretch, moved up four wide in the lane while racing four wide and finished second best. LORD OF TRICKS stalked the pace along the inside and finished willingly to the wire. CODY BOY set all the pace and weakened a bit in the drive. TOP OF THE HERD stalked the pace and weakened. MY ARTY SIDE was slow early, moved up six wide into the upper stretch and never was a serious threat. CASE ON ICE was unhurried early, raced seven deep in the lane and never menaced. BERUDENOTTOO broke awkwardly, raced six deep and never threatened. MATT N MITCH showed little. C O RINGO was off slowly, raced four wide and remained back throughout.
