BLUMIN WON was allowed to settle early, moved up four wide into the upper stretch and finished gamely to get up under all out pressure. R J FANTASY set all the pace from the inside, dug in gamely into the upper stretch and finished willingly to the wire. HOWARD COUNTY HANK was unhurried early, moved up three wide in the drive and made a mild late gain. DRYSPELL was off a step slow, pressed the pace from the inside and faded. ZOE'S LIL BRITCHES was bumped at the start, raced along the inside throughout and never was a serious threat. BUSTER'S BOY failed to sustain a bid. FORTUNE FIGHTER saved ground and never threatened. PENNY FORCE failed to sustain a bid.
