### Footnotes

MINER BIRD stalked the pace, moved up to take command down the backstretch and drew off in the latter stages to be well clear under all out pressure. HOWARD COUNTY HANK was unhurried early, raced towards the inside throughout, moved up in the stretch but was no match for the winner. ROARING MAX was allowed to settle early, moved up six wide into the upper stretch and gained ground in the final stages. MARAVILLOSA MARCOS dropped back early, raced five wide at the eighth pole and had no final winning bid. CURRAGH MON failed to sustain a bid. KING FARHA settled early, raced five wide in the lane and never menaced. MY SON JORDAN stalked the pace and tired. S S STEWBALL set a fast pace from the inside and gave way. FARE CIELO pressed the pace and tired. TURBO ENERGY raced far back and never menaced.
