SAINT CHOCOLATE was unhurried early, moved up five wide in the lane and finished gamely to be clear under strong encouragement. MANDATE MAKER pressed the pace, raced between horses in the stretch and finished willingly to the wire. NOT SO WILD stalked the pace, raced four wide at the eighth pole and finished gamely to the wire. MY SECRET STAR was allowed to settle early, moved up six wide into the upper stretch and made a good late gain. HI PRIM showed good speed from the inside and gave way. BEAN dropped back early, raced four deep and had no response. COUNTY CLERK showed little. MACK'S MONARCH raced five wide through the far turn into the upper stretch and never was a factor.
