**Footnotes**

SOOKIE'S KOOKIES tracked the leaders in the tightly packed field while saving some ground to late backstretch, swung out to challenge six abreast through the far turn, gained the lead through midstretch then needed her best late as GRACIE JANE made a late charge. GRACIE JANE saved ground while never far back, awaited room in behind the wall of horses late in the far turn, swung to the rail once clear and surged late to just miss. T JAYS AFFAIR tracked the lead group racing four and five wide, challenged five wide into the far turn, dropped back a bit into the lane then came again late. GIBSON CRYSTAL stalked the pace from along the inside early, moved to challenge along the rail heading up the backstretch, kept a head in front to upper stretch then was outfinished for position late. SPICE SWIRL prompted the pace from outside ZENA'S AFFAIR to bid into the far turn as the field lined up across the track, lost some ground into the lane and continued evenly. ZENA'S AFFAIR showed the most early speed to cross over and establish position out from the rail, dueled from between rivals through the far turn and weakened a bit late. PROSPECTORS ALYCAT prompted the pace from three wide to join the fray into the far turn between rivals then came up empty in the drive.
