### Footnotes

TENTH POWER settled back off the pace early, rallied five wide through the second turn to take command going to the final turn, opened the lead into the stretch and drew off under hand urging. MINNESOTA SLEW stalked the pace set by ALBERT'S OLLIE while about three wide, lost some ground through the final turn then angled four wide into the lane and held his position while unable to threaten the winner. FLASHY MIKE settled towards the rear of the field racing out from the rail, angled out to move four wide through the final turn and gained third late. WORKIN' THE CROWD saved ground and failed to mount a bid. MEGAWATT JOE stalked the pace racing outside, moved with the winner while inside that one and between rivals then clipped heels leaving the second turn, continued in reach to the far turn and weakened. The rider of MEGAWATT JOE lodged a claim of foul against the winner alleging interference leaving the second turn which was not allowed due to inconclusive video evidence. HOWARD COUNTY HANK saved ground for a about half a mile, angled out through the second turn then moved five wide in the far turn but could not threaten. ALBERT'S OLLIE sprinted clear to make the pace for a half mile then tired heading up the backstretch. CAMARADERIE chased the pace from four wide and tired.
