MY RUFFEN stalked the pace while saving ground, challenged the leader and quickly moved clear midway of the far turn and drew off under hand urging. DONNARAE stalked the pace from three wide and could not go with the winner nearing the lane. FIRST PLACE GRACE moved to a clear lead to establish the pace racing out from the rail, continued to the far turn and had little left nearing the lane. RUBY RED GREEN stalked the leaders in good position racing four to five wide and had no rally. LAWYER LYNN saved ground and failed to threaten. R VOOVOO AFFAIR lacked a bid racing three and four wide. DAZZLING HOPE broke a step behind the field and was outrun racing three wide. TWYLA THE HAWK was always outrun.
