Footnotes

HOWARD COUNTY HANK was the only horse hugging the rail throughout, launched his rally through the second turn to begin picking up rivals, reeled in pacesetting BOLD PARTISAN through the far turn and moved clear late under steady handling. BOLD PARTISAN moved to a clear lead racing out in the three or four path, continued on a clear lead to upper stretch then came up empty late and could not handle the winner. FLOODGATE stalked the pace from four wide while in good position and could not produce the needed late run. FLASHY MIKE stalked the pace racing three to four wide then lacked the needed late response. MINNESOTA SLEW saved ground in reach of the pace and weakened. AGGIES RULE followed the pace racing out from the rail to the far turn and tired. FIESTY FITZ stalked the pace from four or five wide and gave way in the far turn.
