KITTEN IN A PINCH was hustled up inside ADAIR COUNTY to duel on the lead to late backstretch, kicked clear into the far turn then held a safe margin under steady handling in the lane. AFRIENDFORLUCY settled back off the pace racing three wide, rallied well through the lane and gained second. C O STEPHEN chased the dueling leaders racing out from the rail, angled out for the drive and continued evenly. ADAIR COUNTY dueled from outside the winner to late backstretch and weakened through the far turn. BOXERS OR BRIEFS moved up racing three to four wide while not a threat. NERVY saved ground and failed to mount a bid. R KIM TIPPER saved ground and was not a threat. PREACHINGTOWIRE was always back. MR. FROSTY CAT chased the leaders from four wide and tired. RAIN FEATHER floated wide in the first turn and was always outrun.
