### Footnotes

LYNNIES TREAT settled back off the pace racing four wide, rallied five wide in the far turn to come six wide into the lane and continued with a good late run to move off under steady urging. SECRET'S RIFLE followed the pace racing three wide, angled out nearing the lane to rally five wide and moved clear for the place but could not menace the winner. ZENA'S AFFAIR dueled on the pace from outside LA MALINCHE late in the far turn and weakened once headed by the winner in the lane. SHE DOC stalked the pace racing three wide, moved to striking position while angling going to the far turn, awaited room behind rivals through much of that bend then could not rally once clear. AFTANOOON TEA trailed the field for a half mile, moved up outside through the far turn then fanned eight wide into the lane. RUNSANDYRUN saved ground and failed to make a solid bid. HIGH SPEED JUSTICE bobbled at the break, recovered to stalk the leaders racing three and four wide, rallied then checked off the winner's heels late in the far turn and weakened while six wide into the lane. LA MALINCHE dueled on the pace racing out from the rail and inside ZENA'S AFFAIR to late in the far turn and tired. SUEBSAN bobbled at the break, recovered to press the dueling leaders from four wide and tired.
