Footnotes

CHELE'S BELLE soon sprinted clear, angled in some on the bend, in path two into the stretch and held of under steady urging. WOODEN LADY bumped hard and forced into SAFEFORSURE at the break, quickly moved up between horses, prompted the pace two to three wide, lacked the needed late surge but lasted for the place. SAFEFORSURE bumped and forced into RUNAROUNDCAT at the start, was settled, steadily progressed inside, was too late but finished on even terms with CHASEMEIFYOUCAN for third. CHASMEIFYOUCAN forwardly placed outside from the beginning, angled in three wide on the turn, fanned out five wide into the stretch and also steadily closed in the final furlong. SISTER SARA gradually progressed between horses, came four wide into the lane, found best stride too late but was easily best of the rest. JUDGE FOR SALE was soon far back, saved ground on the bend then passed tired ones from inside through the stretch. COLVILLE ZEAL in midpack early, was carried out to six wide early in the turn and came up empty for the drive. RUNAROUNDCAT, bumped after the start, tried to drift out repeatedly from inside, was checked hard as she was getting out early in the turn, drifted out to path five shortly after that and had little left. CELIA BABY bore in at the start, bumped hard with WOODEN LADY, was taken outside, stayed wide and showed little.
