**Footnotes**

THAT SMITH GIRL stalked the pace from outside, drew clear and moved inward on the turn, lengthened command under a drive in the lane and was kept to task to the waning yards. MITH AMERICA in contention behind THAT SMITH GIRL, progressed three wide on the bend, floated out for room into the stretch, lodged a mild rally six wide in the lane and lugged in some late closing the gap. GRUVIANNA blocked behind a wall of horses early, got a clear path four wide on the bend, advanced between rivals to the eighth pole then leveled off. DENOUNCER'S GIRL hesitated then made a small leap from the gate, was angled out on the turn, came six wide into the stretch and passed tired ones. CREST DANCER disputed the pace between rivals, could not stay with THAT SMITH GIRL on the bend, came four wide into the stretch and wore down for the drive. SHESA AXE TOO quickly backed up between horses after the break, was moved to the outside, came three wide into the stretch, advanced to the eighth pole then flattened out. PHONE JOAN vied for the early lead inside but gave way on the turn. DIAMOND ROCK CANDY prompted the leaders from just off the rail but faded on the turn. BETTER PLACE displayed early speed between rivals, faltered three wide early in the turn, was pulled up in the stretch and walked off.
