Footnotes

KING OF THE WIND shared the early lead from outside, angled in some on the turn, floated out to path four entering the lane, was all out between rivals and held on. ILLINI DESTINY contested the pace between horses, backed up some on the turn, swung outside KING OF THE WIND into the lane, came to the latter inside the eighth pole, hung in the waning yards but gained the place. HIGHLAND CONNOR, settled early, picked up his pace just off the inside on the bend, rallied inside the rest in the stretch but was too late. K. O. POSH dueled for the lead from inside, floated out some entering the lane and some more upper stretch, kept a straight path the final furlong, did not have enough left but was easily best of the rest. ALASKAN FIRE raced in contention from outside for more than three furlongs, was widest entering the stretch and weakened for the drive. C'MERE DEAR chased the early speed, swung out to path six for the stretch run and flattened. HURRICANE FURY trailed from inside, floated out for the drive, made up some ground upper stretch then finished evenly. MAD MAX CAT, void of speed, faded three wide on the turn, drifted out into the lane, was empty and allowed to coast to the wire.
